Re: 2018 Farm Bill

Dear <Senator or Representative> <Representative's Last Name>,

I write regarding the 2018 Farm Bill. I am a constituent and a supporter of Slow Food USA, the national, nonprofit organization dedicated to a food chain that is Good, Clean, and Fair for All. Slow Food USA is embedded in 150 communities nationwide, many in <Your State>, and has over 750,000 followers across digital social media platforms. We believe that everyone has the right to enjoy ample, sustainably and humanely produced food that is good for human health and well-being, for our planet, protecting and replenishing our resources, and for those who work to put food on our tables, providing them with dignity and a decent living.

The Farm Bill is the primary legislative vehicle for critical investments in programs that support family farms, rural communities, conservation, and healthy food access to food-insecure Americans. I applaud the swift movement on the House and Senate bills. Given its immense importance, especially in this time of great challenges to American agriculture, it is imperative that Congress completes a new bill, in a timely fashion, before the current bill's expiration on September 30 of this year.

I urge you to work to achieve a bipartisan bill in the best traditions of nearly a century of farm bill history.

Nutrition

Maintain current Supplemental Nutrition Assistance Program (SNAP) provisions and funding to
prevent millions of Americans, including children, seniors, veterans, and people with disabilities,
from losing access to food assistance and reject the counterproductive expansion of work
requirements.

Commodity Supports

- Close loopholes and strengthen means testing, retain payment limits, and require that recipients be actively engaged in farming.

Conservation

- Preserve current funding for the Conservation Title, reject the elimination of the Conservation Stewardship Program (CSP), and retain Environmental Quality Incentives Program (EQIP) funding.
- Support the Agriculture Conservation Easement Program (ACEP) and improve Conservation Reserve Program (CRP) grasslands protection options and provide opportunities for water quality and wildlife protection.
- Grant the USDA authority and funding to measure, evaluate, and report on conservation program outcomes on a regular, iterative basis.

Crop Insurance

- Support strengthened links between conservation and crop insurance and improved conservation outcomes of federal crop insurance, Risk Management education funding and Partnerships, and simplify and strengthen Whole Farm Revenue Insurance.

Agricultural Research

- Increase funding for the Organic Agriculture Research and Extension Initiative (OREI), making soil health a new priority, and improve the National Genetics Advisory Committee, requiring assessment of seed banks.

Local and Regional Food and Rural Development

- Support a new Local Agriculture Market Program (LAMP), the National Organic Cost Share Program, Harvesting Health (Produce Prescription) Pilots, the Food Insecurity Incentives Program, the Rural Microentrepreneur Assistance Program, and Community Food Projects.

Beginning, Disadvantaged, and Veteran Farmers and Ranchers

- Support the combined Beginning Farmer and Rancher Development (BFRDP) and Outreach and Assistance for Socially Disadvantaged and Veteran Farmers and Ranchers (2501) Programs and the Conservation Reserve Program Transition Incentives Program (CRP-TIP).
- Ensure that increased Farm Service Agency (FSA) loan limits do not reduce loan availability for beginning, disadvantaged, and veteran farmers, set aside CSP and EQIP funds for underserved producers and provide advance payments, improve access to Crop Insurance for diversified farms and for beginning and socially disadvantaged farmers, and extend beginning farmer Whole Farm Crop Insurance access to those who have been farming less than ten years.
